VEHICLE ELIGIBILITY

NEW VSA PLANS

Mazda vehicles are eligible if less than 3 years old from date vehicle was first put into service and up to 36,000 total vehicle miles.

PRE-OWNED VSA PLANS

Mazda vehicles are eligible within current model year plus fifteen (15) prior model years and up to 200,000 total vehicle miles. See your dealer for eligibility requirements on non-Mazda vehicles. Pre-Owned Vehicle Plans available through your Mazda dealer only at the time of pre-owned vehicle purchase or lease.
